#### **Historical Note**

The South County Art Association (SCAA) began in 1927 when John W. Dawson invited his artist friends to hold an exhibition at his private studio in Wickford. The group was comprised of prominent Rhode Island artists including Dawson, H. Anthony Dyer, Frank Convers Mathewson, Hilda Anderson, Sydney Burleigh, Herbert R. Cross, Chester Dodge, Anthony Dyer, Lee Jeffrey, Albert McCutchen, Bertha Noyes, Fred Sisson, and Stacy Tolman. Annual exhibits followed, and on June 29, 1929, the group formally named itself the South County Art Association. SCAA officially incorporated in 1937.

According to the SCAA by-laws its purpose is to "promote an interest in art and to encourage artists in Washington County, Rhode Island." Since its inception it has held regular exhibitions, lectures, classes, and fundraisers. Notable members have included Helen Mason-Grose, Rodman Noka, Frank Convers Mathewson, Mathias Oppersdorf, Thomas Ladd, Benjamin de Brie Taylor and others.

Beginning in 1934 the SCAA held annual meetings and exhibits in the Peace Dale Guild Hall. This continued until 1944 when Bernon E. Helme, a civic leader and SCAA member, passed away and bequeathed a portion of his estate to the Association. This endowment was then used to purchase the Helme House in Kingston, which Bernon Helme owned at the time of his death, in 1944. The Helme House continues to serve as the SCAA headquarters today.

In 1930, SCAA members formed a committee to raise money and purchase the Gilbert Stuart Birthplace. This group later incorporated as a separate organization, the Gilbert Stuart Memorial, Inc.

#### **Scope and Content**

The records of the South County Art Association include administrative records, blueprints, correspondence, financial records, ledger books, meeting minutes, newspaper clippings, and photographs. The bulk of the records were created between 1927 and 2000 by SCAA members. The collection has been arranged into six distinct series:
