Historical Note

The *Narragansett Times* is a weekly newspaper that primarily focuses on the towns of South Kingstown and Narragansett, Rhode Island.

Thomas P. Wells (1809-1884) published the first issue of the *Narragansett Times* on May 5, 1855. That same year, Wells hired Duncan Gillies (1830-1881), a Scottish immigrant who learned the trade in New York, to be the newspaper's first editor. Gillies ultimately also became the newspaper's publisher, and he served in both roles until his death.

In 1868 Gillies built the Columbia Building on the corner of Main Street and Columbia Street in Wakefield, which housed the Narragansett Times offices. In 1880 an arsonist set fire to the building, completely destroying it. Subsequently, a smaller building was constructed at the same location that still houses the Narragansett Times offices today.

Following Duncan Gillies's death his son, John, took ownership of the newspaper. The business remained in the Gillies family until 1946, when it was sold to Frederick J. Wilson, Jr. After a period of increased circulation in the 1970s, the newspaper was sold to corporate owners in 1983. Today the *Narragansett Times* is part of Southern Rhode Island Newspapers, and one edition is published each week.

Scope and Content

The records of the Narragansett Times Collection include bound volumes, correspondence, newspapers, and papers. The records in the collection were generated as a result of the newspaper's business operations in the mid-to-late 19th century. The collection also includes a transcription of the judge's instructions to the jury in a libel case against the newspaper in 1891.
