Historical Note

John Knowles Hull (1841-1863) was a sergeant in Company G of the 7th Rhode Island Infantry Regiment during the Civil War. He was born in the village of Tower Hill in South Kingstown, Rhode Island, to Benjamin Hull (1783-1864) and Robey Bowers Knowles (1799-1869). Hull attended the Rhode Island State Normal School in Bristol and worked as a teacher in Portsmouth, Block Island, and South Kingstown. In 1862 Hull enlisted in the Union Army, and his regiment participated in the Battle of Fredericksburg and the Mississippi Campaign. Hull was killed in action on July 13, 1863, in Jackson, Mississippi. He was buried near the site of his mortal wounding, and his personal effects were returned to his family.

Harriet "Hattie" Knowles *Hull* Eldred (1838-1919) was John's older sister. She also attended the State Normal School and worked as a public school teacher. In 1872 she married John Risley Eldred, and they had three children: Mabel DeWitt Eldred, Ralph Dana Eldred, and John Raleigh Eldred.

Scope and Content

The Hull Civil War Collection includes correspondence, digital surrogates, and photographs.

The bulk of the collection consists of letters from John Hull to his sister Harriet during his service in the 7th Rhode Island Infantry Regiment. The letters detail the movements of Hull's regiment, their living conditions, and places and events they saw during service. John's final letter to Harriet was unfinished, and instead it concludes with a note from Sergeant John Webster informing Harriet of John's death. Digital surrogates and transcriptions of the letters are included in the collection, as well as Civil War-era photographs of John and Harriet.
