Historical Note

The Tefft family was among the earliest European settlers of what is now the town of South Kingstown. In 1662 John Tefft (abt. 1614 - 1679) acquired a large tract of land in the Pettaquamscutt Purchase. This land remained with the Tefft family until 1909. John was married to Mary (Barber) Tefft (abt. 1620-1680) and together the couple had four children, Mary Tefft (abt. 1640-1674), Joshua Tefft (1640-1676), Samuel Tefft (1644-1725), and Tabitha Tefft (1653-1722).

Joshua Tefft received notoriety for fighting on the side of the Narragansett Indian Tribe during the Great Swamp Massacre of December 19th, 1675. As a result of his participation he was arrested, found guilty of treason, and executed by the Rhode Island colonial government on January 18th, 1676. There is debate as to why Joshua Tefft fought on the side of the Narragansett due to conflicting testimonies given in the course of his trial.

Little is known about Joshua Tefft's wife, Sarah Tefft. Her gravestone was once thought to be the oldest burial marker in Rhode Island due to a misreading of her death date. However, Craig Anthony, a Rhode Island historian, proved in the late 1990s that her actual death date was March 16th, 1672, two days after the birth of her son, Peter Tefft.

At least thirteen generations of the Tefft family have subsequently lived in the United States. Notable descendants of John Tefft include diplomat Benjamin Franklin Tefft (1813-1885), New York Stock Exchange member Erastus Tucker Tefft (1810-1888), and architect Thomas Alexander Tefft (1826-1859).

There are several spellings, often used interchangeably, of the name "Tefft," including "Tifft and "Tift."

Scope and Content

The Tefft Family Research collection includes a correspondence, maps, manuscripts, newspaper clippings, papers, transcriptions of archival records, and photographs.

The collection is largely comprised of photocopies of primary and secondary source research materials compiled by A. Craig Anthony in the course of writing two books on the Tefft family. These materials relate to John Tefft and his descendants, the trial and execution of Joshua Tefft, and the life of Joshua Tefft's wife, Sarah Tefft.

Anthony believed that Sarah Tefft may have been the daughter of John Greene Jr. and compiled materials related to the Greene family and their property in Warwick. He also attempted to find records relating to Sarah's life before her marriage to Joshua Tefft. Additional materials relate to the significance of the Tefft homestead and cemetery. These include research papers written by Anthony as well as an application to have the area added to the National Register of Historic Places. These records also document the successful efforts of Anthony and members of the Tefft family to block the Blueberry Hill development in the 1990s. The area was purchased by the South Kingstown Land Trust and became Tefft Historical Park.

Other related topics researched by Anthony include a 1787 court case involving Arnold Tefft, a South Kingstown resident, and the locations of historical cemeteries. Also contained in the collection is correspondence between Anthony and members of the Tefft family. Assorted news articles relate to Anthony's research findings and publications as well as 20th century Tefft descendants. The materials in this collection have been grouped by subject. Many of the materials are photocopies that lack clear bibliographic information.
